## Regulations Governing the Selection of Distinguished Professors and Distinguished Teachers of the College of Engineering of National Chung Hsing University

Passed by the extraordinary college affair meeting on May 4, 2011 Amended and passed by the college affair meeting on Feb. 22, 2012 (Articles 4, 5, and 6) Passed by the extraordinary college affair meeting on Apr. 30, 2018 Amended and passed by the college affair meeting on Sep. 9, 2020 (Article 4)

- Article 1 The Regulations are stipulated in accordance with the Regulations Governing the Establishment of Distinguished Professors of National Chung Hsing University and the Regulations Governing the Merit Pays and Rewards for Distinguished Teachers of National Chung Hsing University.
- Article 2 Distinguished professors shall be full-time professors within the staff establishment of the University and shall meet one of the conditions of Article 3 of the Regulations Governing the Establishment of Distinguished Professors of National Chung Hsing University.

Distinguished teachers shall be full-time associate or assistant professors within the staff establishment of the University and shall meet one of the conditions of Article 3 of the Regulations Governing the Merit Pays and Rewards for Distinguished Teachers of National Chung Hsing University.

- Article 3 The selection of distinguished professors and distinguished teachers of the College is reviewed by the Review Committee for the Selection of Distinguished Professors and Distinguished Teachers (hereinafter as the Review Committee) organized by the College.
- Article 4 The Review Committee shall consist of seventeen members the most. The term of appointment is one year. The Dean of the College serves as the ex-officio member and convener. For the remaining members, each department / graduate institute shall select one outstanding scholar from within or without the University with qualification equivalent to the University's chair or distinguished professorship. The department / graduate institute to which the Dean belongs may recommend one external member. The number of external members shall not be less than one-half of the number of total members.

Members of the Review Committee shall not be candidates of distinguished professors. The Dean shall resign his / her position as the ex-officio member if he /she is a candidate of distinguished professor. The convener of the Review Committee shall be elected by other members from among themselves.

A meeting shall not be held unless it is attended by at least two-thirds of the members. A resolution shall not be reached unless it is agreed by at least half of the attending members.

The review criteria for academic research performance of distinguished professors III and distinguished teachers III are stipulated separately.

Article 5 When recommending candidates of distinguished professors and distinguished

teachers, departments / graduate institutes shall submit within the specified time period the candidates' basic information forms for the Ministry of Science and Technology, lists of works, and proofs of specific academic achievements or contributions within the five years before the proposed date of appointment to the College for reviewing.

The works in the lists shall comply with the requirements in the University's Regulations Governing the Review Criteria for Faculty Promotion and Submission of Works for Appointment and Promotion. The application shall be submitted by the primary appointing unit if the applicant for distinguished professorship (distinguished teachership) is an adjunct teacher. Applicants for distinguished professorship III or distinguished teachership III shall submit the College's form for the review criteria for academic research performance of distinguished professors III or distinguished teachers III.

Article 6 The number of applicants for distinguished professorship recommended by each of the department / graduate institute of the College shall not exceed 14% plus 1 of the number of its full-time professors each time.

The number of applicants for distinguished teachership recommended by each of the department / graduate institute of the College shall not exceed 5% plus 1 of the total number of its full-time associate and assistant professors each time. The number of applicants recommended by all independent institutes shall not exceed 5% plus 1 of the total number of full-time associate and assistant professors.

Applicants complying with Article 3 (1) (a) and (b) of the Regulations Governing the Establishment of Distinguished Professors of National Chung Hsing University and the Regulations Governing the Merit Pays and Rewards for Distinguished Teachers of National Chung Hsing University are not included in the aforementioned quota.

Article 7 The Regulations were passed by the college affair meeting and approved by the President for implementation. Any amendments shall follow the same process.
